Buskers are encouraged to perform any time between 10am and 2pm; however, **judging will be conducted from 12pm to 1pm.**

Buskers may sing, play a musical instrument, recite poetry, dance, mime, juggle or perform any other appropriate theatrical art form.

The judges' preference will be weighted towards performances of Australian bush music, bush poetry or entertainment with an Irish flavour.

The entry fee is \$10 per soloist or group. You may receive monetary appreciation from passers-by for your performance but you must not solicit funds in a way likely to offend or cause discomfort.

Performers must not obstruct the flow of pedestrians. Buskers must not perform in an offensive or dangerous manner including the use of offensive language. Buskers must perform at a volume acceptable to festival organisers. Offenders will be disqualified. Electricity is not available.

The judges' decision will be final. No further correspondence will be entered into. The results will be announced at the main stage after the competition closes. Arrangements will be made for the winners to collect their prizes from Custom Music and the Cad Factory.

Entry fee is \$10 which may be paid accompanying a completed entry form to:
